Agenda Notes/Status Report

Status: In response to questions from the client, we clarified several items from the Monthly Status Report. Specifically,

we described the type of tests we ran and the purpose thereof, which included running I/O and port accesses for the purpose of

getting deterministic results and implementing control, jump, and intensive instructions on the processor. The goal was

to obtain deterministic results, which meant running tests over and over again and comparing the results.

Data was stored and fitered in order to examine and compare peaks and timestamps.

For the data capture, we used the o-scope directly because the amplifier did not give us enough amplification.

We had a meeting with Dr. Robert Heckendorn, a computer science professor who teaches classes on machine learning and bioinformatics, to

discuss possible algorithm choices such as SVM (Support Vector Machine).

He recommended that we consider sequence matching algorithms that are used for bioinformatics and genome sequencing.

Such algorithms work by aligning adjacent sections of longer sequences and adaptations or variants thereof may be well suited to this project.

With a sequence alignment algorithm, we hope to be able to compare regions between sequences of waveform peaks distributed over time.

At this point, we are exploring multiple avenues and need to gather data and perform tests in order to determine which algorithms are best

suited to our needs.

We discussed the antenna and box design. Roy found a solution to use a small wire and a loop antenna.

For PDR, our plans are to identify one to three of the most promising algorithms, describe how we intend to capture data,

and propose a design with boot code. The client may travel to Moscow to be present at PDR, which will most likely be on or near 11/15.

* Key Decision: Information such as test setup, explanations on why amplifier did not work, details about tests and results, and more general context are needed for the Monthly Status Report.

* Key Decision: Test and debug the amplifier.

* Key Decision: We need to increase the amplitude of the signal in order to get meaningful information.
