Build a unit for synchronizing the power system in the advanced power lab to the Avista system. This action item is going to change to configuring a SEL-351 so that it can be used to synchronize the system. I plan to get a copy of the 351 documentation at work. (10/16) Due 3/15

Review the motors textbook to assist with understanding the test we are doing from the IEEE standard and any workarounds that will be needed in the lab. Update: I have started reviewing the textbook, especially on the slip questions that came up during the design review. I still need to work on understanding the motor tests we are doing and how the IEEE test will be modified since we cannot supply a voltage higher than 240V to the VFD.

AI:37 Everyone Due 12/3 Done

Review the parameters of the VFD to determine if there is any opportunity to enter characterized values from the motor work into the VFD. 12/3, done. The VFD does not have parameters that we can edit directly. Two emails were sent out as a follow up to this action item. They are included for reference here:

There are two important updates I would like to send out to everyone.

- 1. The VFD does not have parameters that can be modified by the user specific to motor characteristics like stator resistance, stator inductance, rotor inductance, etc.
- 2. The VFD does have the ability to receive feedback directly from an encoder, but not the one we have.
- a. The encoder has to be a pulse style encoder with an A and B pulse. A leading or lagging B would indicate direction. The VFD also has support for a Z pulse (zero pulse).
- b. We do not have this type of encoder. The encoder we have provides a 13 bit binary value indicating the rotors absolute position. The VFD cannot decode our encoder signal.

We know from the description in the figure below that the VFD parameterizes the motor in two possible times, both of which are mutually exclusive from one another. The ID run is described as "a self-calibration process... the drive operates the motor (motor rotating) and makes measurements in order to identify motor characteristics and create a model used for internal calculations." The ID run actually turns the motor during its calculations. A bit further down, it mentions the "Identification magnetization is performed, depending on parameters 9904 and 2101... the motor model is calculated at first start by magnetizing the motor for 10 to 15 s at zeros speed (motor not rotating). The model is recalculated always at start after motor parameter changes."

Note that the description states "if motor parameters are changed after the ID Run, repeat the ID Run".

The motor parameters are listed as follows:

2601: FLUX OPT ENABLE – changes the magnitude of the flux depending on the actual load.

2602: FLUX BRAKING – Provides faster deceleration by raising the level of magnetization in the motor when needed

2603: IR COMP VOLT – Sets the IR compensation voltage used for 0 Hz.

2604: IR COMP FREQ – Sets the frequency at which IR compensation is 0 V (in % of motor frequency)

2605: U/F RATIO – Selects the form of the U/f (voltage to frequency) ratio below field weakening point (linear or squared)

2606: SWITCHING FREQ – Sets the switching frequency for the drive (default is 4kHz).

2607: SWITCH FREQ CTRL – The switching frequency may be reduced if the VFD internal temperature rises above a limit.

2608: SLIP COMP RATIO – Sets gain for slip compensation (in %).

2609: NOISE SMOOTHING – This parameter introduces a random component to the switching frequency.

2619: DC STABILIZER – Enables or disables the DC voltage stabilizer.

I do not know if this is all inclusive, or if we even have access to all the parameters that are calculated. I had considered recording all the parameters, running the ID RUN, then checking to see what the machine changed. Still, a thorough review of all parameters available only reveals parameters like accelerations, decelerations, curve shapes (linear or s), and so forth. There are no parameters (other than name plate values) that are named after specific motor characteristics.

Ask Mike West about how he set up the VFD parameters in the beginning. Mike didn't do any improvements to VFD parameters beyond entering the nameplate values. He specifically did not do an ID RUN.

Chad

New Minutes

New list of questions:

Dr. Fischer stated in the design review that it was not important to have lightening fast response to changes in frequency. Furthermore, he said we want the system to replicate the response of prime movers in the power industry. Two examples were a steam turbine and a hydro-powered turbine.

- It feels like we have had another large shift in the paradigm of our goals. We have consistently used the terms "fast as possible" and "small as possible" in our documents that have been reviewed by our technical advisors, but now it sounds like neither of these are true.
- Dr. Fischer specifically said "The VFD is capable of responding instantly. We do not want that... we do not want the VFD in the RTDS model."

Two reasons to characterize the machine. The parameters of the machine can be entered into the drive to tune the drive.

It is also worth have a simple model of the machine and the drive in the RTDS. The dynamics of the drive may not be very noticeable since the machine will be responding so much faster than the prime movers in the final model.

Dr. Johnson provides a book that has models within it. They are block diagrams but they have to have parameters added to it.

Dr. Johnson has the report and some other material for the power grid design team from a couple of years ago. He is going to provide this information to us.

Hatem asks about the time delay. The block diagrams are similar to what you have seen in signals courses. Our job is filling in the information for the block diagrams.

Kayden asked about who Doug Taylor is. He is an SEL engineering that relocated to Spokane.
